## Requirements

### Eligibility

This is an OPEN juried exhibition, and all artists of miniatures are invited to participate. Work submitted must be original work by the artist.

### Size

Artwork may not exceed 48 square inches (including mat and frame), with a maximum art work size of 25 square inches. The 1/6th rule will be applied when entries are juried (Exceptions where applicable). Sculptures may not exceed 6in x 6in x 6in, including the base.

### Media

#### Acceptable media are:

- Drawing (pencil, charcoal, ink, pastel, and colored pencil)
- Paintings (water color, acrylic, oil)
- Mixed media
- Sculpture/3 Dimensional

### Framing

All work must be presentation ready. (no saw-tooth hangers). All water colors must be under glass or Plexiglas.

### Labeling

All works must have the following information affixed to the back of each piece:

- Title of the work
- Medium
- Price
- Artist's full name

### Categories

Awards will be given in the following categories: Still life - Animal - Portrait - Landscape - Seascape - 3 Dimensional.

## Procedures

### Entry Fees

\$40.00 for up to six submissions; \$30.00 for up to three submissions; and \$15.00 for a single submission. With a minimum of four entries, an artist is entitled to one NFS. All other works must be for sale. The Gallery will take a commission of 30% on all sales. Entry fees are non-refundable and must accompany the entry form. **All entry fees should be in US Dollars and made payable to the SIERRA ARTIST GALLERY.**

### Delivery and Pickup

All entries, either hand delivered or by mail, UPS or FedEx, must be received no later than Mar 10, 2017. Coverage of the cost of return postage is the responsibility of the exhibitor. **SELF-ADDRESSED, PREPAID RETURN POSTAGE MUST ACCOMPANY ARTWORK!** All artwork not submitted with SELF-ADDRESSED return postage becomes the property of the Gallery at the end of the Exhibition. Pickup and return mailing of entries will be after 3:00 pm, April 3, 2017.
